2. The bidder must quote the complete rate inclusive of Taxes.
3. The quotation should clearly mention the rate per Identity Card, including printing and all accessories/materials, as applicable.
4. The quantity of Identity Cards may be increased or decreased as per the actual requirement of the College.
5. Printing shall be carried out strictly according to the format, specifications, logo, photograph, signature and other details approved/provided by the College.
6. Any defective, damaged, incorrectly printed or otherwise unacceptable Identity Card shall be replaced by the supplier at no additional cost to the College.
7. The supplier shall be responsible for the safe delivery of the Identity Cards to Kishan Lal Public College, Rewari without any extra cost.
8. Payment shall be released after satisfactory supply, inspection/verification and submission of the bill/invoice as per college rules.
9. The College reserves the right to accept or reject any or all quotations without assigning any reason.
